

VILLAGE OF SCHILLER PARK'S SNOW REMOVAL PROGRAM GUIDELINES, QUALIFICATIONS & APPLICATIONS

QUALIFICATIONS: Resident must be 65 or older. If under 65, resident must be disabled and have no other person residing in the household that is able to shovel snow.

Residents under 65 must obtain a medical verification note from their physician stating that they are unable to shovel snow. This will stay on file at the Village Hall.

GUIDELINES OF PROGRAM:

An application must be completed with requested services and signed on an annual basis.

The snow removal services are done by an independent contractor that is hired by the Village. Snow removal of driveways & sidewalks will occur after 3 inches of snow fall.

The resident shall pay the following for the services requested:

- Snow removal of the driveway \$15.00 per occurrence.
- Snow removal of the path from the house to the driveway or to the alley \$5.00 per occurrence.
- Snow removal of the public sidewalk in front of your home \$5.00 per occurrence (\$10.00 for corner lots).
