**ACKNOWLEDGEMENT – Exterior Liquor Sales Permit**

I, \_\_\_\_\_ (print name), of \_\_\_\_\_ (name of establishment), do hereby acknowledge and agree that I have been granted an “exterior sales permit” pursuant to Section 110.33(C) of the Schiller Park code, which authorizes “the retail sale of alcoholic liquor for consumption on or within any beer garden, patio area, or other similar outside or unroofed or unenclosed areas adjoining and utilized in conjunction with a premises for which there is a then currently issued and valid [liquor] license.”

\_\_\_\_\_ (initials) I understand that the exterior sales permit therefore addresses the sale of alcoholic beverages and does **not** grant an absolute right to have outdoor music, whether electronic or live, but that I must abide by all code provisions, including those related to noise levels and hours of outdoor music and sound.

\_\_\_\_\_ (initials) I have reviewed Title XI, Section 110, Alcoholic Beverages, Section 110.33(C) (5) and (7) ([https://codelibrary.amlegal.com/codes/schillerpark/latest/schillerpark\\_il/0-0-0-6402](https://codelibrary.amlegal.com/codes/schillerpark/latest/schillerpark_il/0-0-0-6402)) and Section 110.76 ([https://codelibrary.amlegal.com/codes/schillerpark/latest/schillerpark\\_il/0-0-0-6557](https://codelibrary.amlegal.com/codes/schillerpark/latest/schillerpark_il/0-0-0-6557)) of the code of the Village of Schiller Park. The following is Section 110.33(C)(7), to which I agree to abide and adhere:

**§ 110.33(c)**

*(7) Any type of live entertainment or music produced by any mechanical or electronic means shall not be allowed before 12:00 p.m. or after 10:00 p.m. in the area covered by the exterior sales permit if any portion of the permitted area is located within one hundred feet of any residential zone, as measured from the boundary line of such residential zone to the permitted area, unless specifically authorized in writing by the Local Liquor Control Commissioner for a specific special occasion or event. In addition, no live entertainment or music produced by any mechanical or electronic means shall at any time emanate from the interior or exterior of any licensed establishment that unreasonably disturbs the peace or quiet enjoyment in any residential zone.*

\_\_\_\_\_ (initials) I understand that if a Schiller Park police officer asks me to turn down any music, live or electronic, or to have patrons lower the level of conversations, that I will immediately do so.

\_\_\_\_\_ (initials) I understand that Section 110.55 of the code states that consumption outdoors can only occur in an authorized and approved designated area. I agree not to alter the designated area approved under this exterior sales permit without first obtaining written approval from the Schiller Park Liquor Commissioner.

\_\_\_\_\_ (initials) I understand that the Local Liquor Control Commissioner may revoke or suspend any license issued by him if he determines that cause exists for such revocation or suspension by reason that such licensee has violated any local ordinance or state law; or violated any applicable rules or regulations established by the Local Liquor Control Commission, or for other reasons set forth in Section 110.75(A) of the Village code.

\_\_\_\_\_ (initials) I understand that the Schiller Park code allows for the filing of a complaint by 5 or more residents to subject my liquor license to a fine, suspension or even termination (per Section 110.76). A ticket/ violation can be written under C7 and issued against me, and once adjudicated, a hearing can be held to fine or revoke the exterior permit that was issued to my establishment.

\_\_\_\_\_ (initials) I have also received a copy of and reviewed Title IX, Section 94, Noise, and understand that I must comply with that section and to keep any exterior sounds to a level that does not disturb residents.
